## PINELLAS COUNTY CHILD WELL-BEING DATA SOURCE GUIDE

Demographics & Economic Well-Being Sections: Information in these two sections was sourced from the American Community Survey (ACS) conducted by the US Census Bureau. The ACS is an annual survey. The estimates are for a five-year period. The ACS estimates were averaged over the 2014-2018 time period. Unless noted otherwise, "children" and "grandchildren" refer to those under age 18. Numbers in parentheses are percentages of the number shown for the indicator. For example, an estimated 51,403 children under 6 years old were living in Pinellas County for the period 2014-2018. This number represents 32.2% of children under 18 in Pinellas County. This information is based on the number of children in households for whom poverty status could be determined. Currently responsible for most of the basic needs of any grandchildren under the age of 18 who live in this house or apartment U.S. Department of Commerce, U.S. Census Bureau, 2014-2018 American Community Survey 5-Year Estimates, Tables B10001, B10051, B11004, B25106, B27001, DP05, S0901. Retrieved from <u>https://data.census.gov/</u>. For various technical reasons, the estimates produced by the Census Bureau for sub-groups do not always sum to the total for a given characteristic. Children's race is an example. The number of children under 18 years who define themselves as being one race (white only, Black or African-American only, etc.) is estimated by the Census Bureau as 3,872,481. However, when all the racial groups are added together, the total of children who are white, Black or African-American, Asian, and all other races is 3,659,495. In addition, the "Children in Households Below ALICE Threshold" was sourced from United Way Florida's ALICE site [American Community] Survey, 2016, and the ALICE Threshold, 2016]
