#### **Nomination and Selection Criteria**

- Nominee consistently performs above and beyond their job description/requirements to serve the children and families of Pinellas County.
- Nominee is an inspiration to co-workers and to clients (children and/or families they serve).
- Nominee's efforts have helped improve the condition of a group and/or individual.
- Nominee is an employee in good standing of an employer with a Pinellas County program.
- The nominee's <u>primary duties</u> are to provide direct services to children and/or families NOT to supervise, manage, direct, or oversee a program.
- Classroom teachers above the pre-kindergarten level are NOT eligible. However, other public or private school employees, such as social workers and guidance counselors, are eligible.
- The nominee may not be an employee or family member of the Juvenile Welfare Board administration or executive leadership.
