

H. Browning Spence Education Award Nomination Criteria

Thank you for nominating a young person for the **H. Browning Spence Education Awards**, monetary awards to assist with the educational needs of promising youth who are preparing to exit or who have exited the local foster care system, or who are unaccompanied or homeless.

<u>PURPOSE</u>: The special role of the H. Browning Spence Education Awards is to assist youth ages 17 to 21 who desire to further their education or career goals but may be struggling due to financial or other circumstances. The award was created in 2010 to honor JWB Deputy Director Dr. H. Browning Spence, his 24 years of service to the Juvenile Welfare Board, and his dedication to the well-being of Pinellas County children.

FINANCIAL EDUCATION AWARDS: Three promising youth ages 17 to 21 will be selected to receive a monetary award to support their education in the amount of \$1,500 each.

ELIGIBILITY:

- Youth ages 17 to 21 who are preparing to exit or who have already exited foster care, or who
 are unaccompanied or homeless, are eligible to receive the award. Youth must have lived at
 one time or still be living in Pinellas County to be eligible.
- Nominations must be made using the online form that can be found by <u>CLICKING HERE</u>. A brief essay written by the youth being nominated must be emailed as a PDF file to <u>Communications@jwbpinellas.org</u>. Both the online form and youth essay must be received by the nomination deadline: <u>Monday</u>, <u>April 1</u>, <u>2024</u>, at 12:00 <u>PM</u>.
- All youth nominated must be available to attend the Annual KidsFirst Awards Luncheon on Friday, April 26, 2024, from 11:30 AM to 1:00 PM at the Coliseum, 535 4th Avenue North, St. Petersburg. The top award recipients will be publicly acknowledged and receive their monetary awards/checks at this event.
- Youth recipients may be asked to give brief remarks at the luncheon event, sharing what the
 award means to them and reading a <u>brief</u> excerpt from their nomination essay. JWB will
 provide a public speaking coach to assist youth in preparing their brief remarks.

NOMINATION & SUBMISSION DEADLINE: The nomination deadline is Monday, April 1, 2024, at 12:00 PM. Both the online nomination form and brief essay written by the youth being nominated must be received the deadline. The online form can be found by CLICKING HERE, and the youth essay should be saved as PDF file and emailed to Communications@jwbpinellas.org.

REVIEW & SELECTION: All eligible nominations will be reviewed and ranked by a selection committee that includes individuals from the Spence Family and JWB Board.

<u>AWARDS</u>: Awards will be announced on April 10, 2023, at which time the nominator and nominee will be notified. All youth recipients will be honored with a monetary award during the **Annual KidsFirst Awards Luncheon on Friday, April 26, 2024, from 11:30 AM to 1:00 PM at The Coliseum, 535 4th Avenue North, St. Petersburg, FL. Youth recipients and one guest each will receive complimentary tickets to the luncheon, along with speakers' coaching for their acceptance speeches, and funds for appropriate event attire, as needed.**
