- a. Stephen Foshley with Caregivers Support Services (CSS)
- b. Funded by JWB and a part of the Children's Home Network. Their focus is in reducing acute stressors thus reducing child abuse and neglect by providing wraparound services to caregivers. Their program is usually 3-6 months (can extend to 8-9 months), providing short-term respite services, center-based care (daycares), and group care. They provide services to any parents or Caregivers, caring full-time for a child age 0-14 and living in Pinellas County. If you would like to make a referral, contact them at (727) 460-7947 or css@childrenshomenetwork.org . NOTE: No social security/documentation is needed to receive services.
- c. Families can request respite services at any time operating between the hours of 8 a.m.-10 p.m. On average families use respite services 3-4 times a week for 3-4 hours.
