- b. South County Literacy Update
 - i. Kim, Valarie, and Kelly recapped the outcomes of the SCCC Literacy Subcommittee meeting held in June with Kim L. from Y Reads and Brianna Ray from the JWB Grade-Level Reading Initiative. The outcomes were as follows:
 - Support for the Y Reads Fall Festival This event takes place in November and includes all Y Reads locations (three in Mid County and eight in South County). It will be held at the Lealman Exchange Center. Council members will volunteer at the event, assisting at the JWB table and in other capacities as needed.
 - 2. Family Engagement Nights Each center is required to host 3–4 family engagement nights. SCCC will support one of these events in South County.
 - 3. Literacy Volunteer Call-to-Action Flyer A flyer will be created to promote volunteer opportunities, including details about the Y Reads program and the Seniors in Service Grandparents Program.
 - ii. Daphne noted that the Fall Festival is located in Mid County and expressed interest in supporting an event in South County. She also suggested inviting Kim L. from Y Reads to attend a council meeting to explain her program. Kelly clarified that providing transportation to the event is not withing our capacity. The discussion concluded with the subcommittee agreeing to follow up with Y Reads and inform them that the council would prefer to support Family Engagement Nights in South Pinellas County.
